Graduate Diploma of Business Administration

The Graduate Diploma of Business Administration is one year in duration for a full-time student. Each year consists of three 12-week Study Periods, also known as Trimesters.

Core subject - a compulsory subject that you must complete

Elective subject - a subject you must choose from the Elective Bank below

Pre-requisite subject - a subject you must complete before undertaking another subject

This course comprises 8 subjects that you are required to complete: 4 core subjects and 4 elective subjects.

RPL - Should you have any Recognition of Prior Learning (RPL) credits that make you eligible for subject exemptions, please contact your Program Director to discuss further.

NOTE: This course is delivered ON-DEMAND without any timetabled classes. It is not suitable for any student on a student visa. Other versions of this course are available for such cases. Please ensure you follow the correct Study Guide for the course you are enrolled into.

How to read the below Suggested Study Pattern (as a Full-Time Student):

8 subjects per year make up a full time study load, following a 3 subjects - 3 subjects - 2 subjects pattern across the year's three Trimesters.

As an example, following the below recommended study path, the subjects in your first year would be:

1st Study Period: BMKTHD600, BMGTHD600 & 1 Elective (3 subjects) We strongly recommend you take BMGTHD502 as your first elective 2nd Study Period: BMGTHD601, BFINHD600 & 1 Elective (3 subjects) We strongly recommend you take BMGTHD501 as your second elective 3rd and final Study Period: 2 Electives from the Elective Bank (2 subjects)

Studying Part-Time? You would still follow the below sequence from top to bottom, but with fewer subjects per Study Period. Fast Track? You can accelerate your studies by taking up to 4 subjects in each trimester.
