What is i2i?

i2i is a cloud based and secure Standards Management solution offering from Intertek Inform, that allows you to easily access standards. Access to i2i allows you to either view the standards online or download a copy

How will I access i2i?

Upon registration, you will receive an email from i2i, 2 weeks prior to course commence. The email will provide credentials to login to i2i with a username and password. After the first login, you will be prompted to change the password to a personal one. Please ensure you change the password and retain the password securely.

Standards are protected documents by Digital Rights Management. Vitrium is the digital rights management solution (Vitrium) to comply with the publishers' needs, and to enable you to access Standards easily, securely, and confidently without breaching license requirements.

Adobe Reader or PDF Exchange are the only supported readers of the PDF documents you wish to download. Vitrium will apply the required watermarking to the standards and will continue to prevent sharing or storing on another device. Why is the Standard protected as a DRM(digital rights management) pdf?

Intertek Inform(Previously SAI Global Standards now rebranded to Intertek Inform), supply Standards from many publishers. Standards Australia have updated how their content can be used and require Intertek Inform to ensure that users are not able to breach their licence requirements. As a result, we have implemented technology that limits usage of Standards Australia content to only what is allowed in the licence agreement. This includes:

- Access to open and save the document for one user on one device.
- Ability to print the document twice
- No ability to cut and paste from the document

What are the DRM systems required to download and print a copy of the standard?

As the standards have specific requirements to protect copyrights and the way intellectual property is disributed, you can access DRM protected pdf's by using a supported PDF reader or an app if you access the pdf on your mobile.
