- Hand out the fundraiser brochure along with your contact info as a leave-behind for any questions they may have
- Invite participants to experience the benefits of using only water and Norwex Microfiber
- Determine a timeframe for your fundraiser, no more than 30 days
- Prizes are cumulative

Tax Exempt Information

Some organizations are sales tax-exempt.

Before a Consultant places a fundraiser order for a tax-exempt organization, Norwex Canada Inc. must verify and document the sales tax-exempt status. To receive approval, a Consultant must submit the following on behalf of the tax-exempt organization:

- The organization's Tax ID number
- Sales tax-exemption form/tax-exempt certificate

Once sales tax-exempt status has been verified, the fundraiser for that organization will not be charged sales tax.

How do Customers pay?

 The participating organization collects all funds for their sales and issues one cheque to the Consultant. The Consultant then provides his/her credit card information to Norwex to process the final payment.

How do I pay for the final order? Consultants will submit one payment for the final order. The full amount will have been received from the sellers.

How do I receive my 20% commission? When completing your fundraiser order, the full amount due must be paid by the Consultant. The 20% Consultant commission will be paid into your Account Balance. Funds in your Account Balance are paid out twice monthly. To view your Account Balance go to your Consultant Office > My Business > Commission Summary.

Who does the final order ship to?

The final order will ship to the Consultant to check and sort. When you deliver the order to the participating organization, ask the representative for the organization to sign the picking slip to confirm that all products have been received.
